





- Developed Swing Spaces (to accommodate Students <u>during</u> Construction)



SED Maximum Cost Allowance (MCA):


- Decision on Phased or Complete Projects
- Costs Cannot Exceed Approved MCA & \$435M Budget
- Legislation Allows Up To 25 Projects, and District-Wide Technology (Phase II)
- Core Model Program... Facilities for Learning

'Consensus' Swing Space Strategy

Candidate Schools (Highest Need by Zone):

- Northwest has 11-Possible Schools
- Northeast has 10-Possiblities
- South has 16-Possibilities

Initial Phase 2A Recommendation: School 7 as a PK / 6 Facility


Major Supporting Rationale:

- Complete Reconstruction of a School
- Addresses Need for Seats at Elementary Grades
- Removal of Obsolete Moveable Partitions
- Removal of Obsolete Modular Classrooms
- Replacement of Obsolete M/E/P (Mechanical/ Electrical/ Plumbing/), Tele/Data Infrastructure

Swing Space: Required & Under Study Compliance with Core Program Highlights

- All Classrooms will Meet SED Minimum Area
- New Stage Creates a Flexible Cafétorium

Target Milestone: Complete in 2018



Phase II Strategic Plan: Northeast Zone

Initial Phase 2A Recommendation: East Lower (6/8) & Upper (9/12) Campus

Major Supporting Rationale:

- Required by State Receivership in the EPO (Education Partnership Organization) Agreement with U of R
- One of District's Largest Buildings with Most Obsolete Infrastructure Mechanical/Electrical/Plumbing/ Envelope & Overall Energy Saving Needs
- Over 90% of Classrooms are Below SED Minimum Usable Area Standards

Swing Space: Not Desired (still pursuing)
Compliance with Core Program Highlights:

- All Classrooms will Meet/Exceed SED Minimum
- Comprehensive Network of Support Spaces

Target Milestone: T. B. D.






Phase II Strategic Plan: South Zone

Initial Phase 2A Recommendation: Monroe High School (7/12)

Major Supporting Rationale:

- One of District's Oldest Buildings with Most
 Obsolete Infrastructure Mechanical/Electrical/
 Plumbing/Envelope & Overall Energy Saving Needs
- Cafeteria and Over 50% of Classrooms are Below SED Minimum Usable Area Standards
- Gym Court & Pool Below Minimum Regulation Size
 Swing Space: Currently at Marshall
 Compliance with Core Program Highlights:
- Completes Full Reconstruction of the School
- Exploring Regulation Play Field Possibilities

Target Milestone: Complete in 2017




Phase II Strategic Plan: South Zone

Initial Phase 2A Recommendation: School 16 (PK/6)

Major Supporting Rationale:

- Complete Reconstruction of a School
- One of District's Oldest Buildings with Most Obsolete Infrastructure – Mechanical/Electrical/Plumbing/ Envelope & Overall Energy Saving Needs
- Over 60% of Classrooms (CR's) are Below SED
 Minimum Usable Area Standards
- Removes Obsolete Modular Classrooms
 Swing Space: Currently at Freddie Thomas
 Compliance with Core Program Highlights:
- Over 70% of CR's will Meet/Exceed SED Minimum
- Comprehensive Network of Support Spaces

Target Milestone: Complete in 2018



Phase II Strategic Plan: Next Steps

Transparency: Continue to seek Input & Comments from the District, the City, & Stakeholders


Focus the Investments: Pursue SED Decision on Complete rather than Multi-Phase Approach to Projects

Validation Process:

- Refine Strategic Plan Regarding Program Compliance,
 Probable Costs, Constructibility, & Phasing Strategies
- Recommend School Projects Beyond Phase 2A
- Develop Business Opportunities & Workforce Development Programs
- Update Financial Plan for Phase 2

Master Plan Schedule:

- Submit Plan for District Approval in March 2016
- Submit Plan for State Approvals in April 2016
