Earlier this year, a new law came into effect that directed the Commissioner of Education to appoint a Monitor to provide oversight, guidance and technical assistance related to the academic and fiscal policies, practices, programs and decisions of the Rochester City School District, the Board of Education, and the Superintendent. This law requires that the Monitor to conduct public hearings on three issues. The first hearing sought public comment on the existing statutory and regulatory authority of the Commissioner, the State Education Department, and the Board of Regents regarding school district governance and intervention under applicable State law and regulations.
