RCSD Timeline

March 13, 2020: Last Day of In-Person Instruction April 2020: 3-8 State Assessments Canceled

May 19, 2020: New Superintendent Appointed May 2020: June and August 2020 Regents Exams Canceled

July 2020: Plan Submitted to NYSED August 2020: RCSD Decides to Go Full Remote October 2020: Decision to Offer Hybrid Instruction beginning January 4, 2021

November 2020: January 2021 Regents Exams Canceled



Hybrid Model for Students with Disabilities in Specialized Programs (K–12)*

Hybrid for All Students (Pre-K-12)* Remain Remote for General and Special Education Students (Pre-K-12)



Reopening Schedule: January 4, 2021



• K-12 Specialized Programs Hybrid

- Students will attend Edison, #28, or #45
- Appropriate Specialized Services Staff Will Report In-Person
- All Other Pre-K–12 Students Remain Remote



Proposed: Pre-K–12 Hybrid Implementation Timeline

January 4, 2021 Phase 1*

• K–12 Specialized Programs

- K–8 Students in Specialized Programs Attend Home School (except East and Franklin Lower)
- 7–12 Students in Specialized Programs Attend Edison (including East and Franklin Lower)
- All Other Pre-K–12 Students Remain Remote



- Pre-K–6 General Education and Special Education
 - Hybrid Students
 Attend Home School
- 7–12 Students in Specialized Programs remain at Edison (including East and Franklin Lower)
- 7–12 Regular and Special Education Remain Remote

Third Quarter Phase 3* • 7–12 General **Education and Special** Education • Hybrid Students, including Specialized Services Attend Home School


*Families will have a 100% Remote option available


