WHEREAS, under the Act, the RJSCB has certain enumerated powers to act as agent for the District, the City, or both; and

WHEREAS, the Act authorizes the RJSCB to finance up to \$325 million for the renovation of up to thirteen school projects (each a "Project" and collectively, the "Projects"); and

WHEREAS, the Act encourages the RJSCB to seek public input into the Projects; and

WHEREAS, following numerous public meetings, the RJSCB has developed a preliminary plan for specific school renovation Projects; and

WHEREAS, the RJSCB is committed to ensuring that the projects support the educational objectives for students by assuring that building stakeholders have an active voice in the design process; and

WHEREAS, the RJSCB is committed to ensuring that the neighborhood stakeholders for each project also have an active voice in the design process;

THEREFORE, BE IT RESOLVED:

- 1. That Building Advisory Committees be established for each project in the Rochester Schools Modernization Program through the cooperation of the RJSCB Program Manager and building principals.
- 2. Each Building Advisory Committee will represent Rochester City School District parents, students, staff and neighborhood stakeholders unique to each project.

Architect Selection

WHEREAS, the Rochester School Facilities Modernization Program Act ("School Modernization Act") established the Rochester Joint Schools Construction Board ("RJSCB"), a seven voting member board consisting of equal representation by the City of Rochester ("City") and the Rochester City School District ("District"), as well as a member jointly selected by the City and the District; and

WHEREAS, under the School Modernization Act, the RJSCB has certain enumerated powers to act as agent for the District, the City, or both; and

WHEREAS, the RJSCB identified qualified architectural firms for Phase I of the Rochester Schools Modernization Program (RSMP) using a Request for Qualifications process in keeping with its timeline for construction that will commence Summer 2012; and

WHEREAS, the RJSCB subsequently issued a Request for Proposals (RFP) for Architectural Services, Renovation and Addition Projects; and

WHEREAS, the RJSCB's Procurement Policy stipulates that the MWBE and Services Procurement Committee shall select finalists and conduct interviews for professional service contracts (Article 2 Section 1(e)); and

WHEREAS, the Committee selected nine finalists following the review and consideration of recommendations provided by the RJSCB Program Manager; and

WHEREAS, these finalists were then interviewed by Committee members, Program Manager representatives, and District representatives; and

WHEREAS, after due deliberation by the Committee, the following firms were identified as being highly qualified and fiscally responsive to the RJSCB's Rochester Schools Modernization Program for the specific projects set forth below;
