#### 1. Amendment #24 to Vargas Associates (Move Manger)

- Tom Richards stated that the Baker Tilly Forensic Report will be received by the Board on Monday. Public release will be held until review of the document with the Board of Education and City Council. The Special Committee met yesterday regarding the ongoing investigation. The Board, Tom Renauto, and Gilbane remain witnesses, not targets, of the investigation.
- 3. Tom Richards stated that the Agreement between the RJSCB and the Executive Director related to legal expenses incurred as a result of the government investigation will be voted on at the Board meeting on Monday. This issue has been discussed in the past and the document has previously been sent to the full Board electronically. It was handed out in hard copy at the meeting.
- 4. Tom Renauto updated the members on the status of the LeChase claim at School 58. Tom stated that the latest letter received yesterday is the final response from LeChase following several meetings and revisions. Tom Renauto and Peter Abdella have been working on a cooperation agreement between the RJSCB and LeChase regarding potential future litigation with the Architect and one of the Prime contractors. The draft document has been sent to LeChase for review. We are expecting their comments next week. Once a final version is complete it will be shared with the Board. Tom Renauto will bring an amendment to the Board on Monday for the claim resolution.
