#### 1. Phase 2 Budget Report

Pépin Accilien reviewed the report with the Committee. All pending change order items brought to the Committee were included and tracking well. Expenditures (hard and soft costs) for the first group of projects in Phase 2a total \$163,507,573.47 Expenditures (hard and soft costs) for the second group of projects in Phase 2b total \$137,962,667.61 Expenditures (hard and soft costs) for the third group of projects in Phase 2c total \$113,874,792.38 Expenditures (soft costs) for the fourth and final project for Phase 2d total of \$24,501,232.33 Total amounts paid to date for all Phase 2 projects total \$439,846,265.79 of the \$435M borrowing limit and the approximately \$16M of supplemental funds (i.e., SSBA, CSG, NYSERDA Rebate, RG&E Rebate).
