We, as a School, will support our students' academic learning and achievement in the following ways:

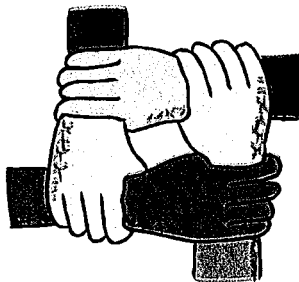

- ✓ **Provide parents with frequent reports on their children's progress. Specifically, the School will provide reports as follows:**
 - *Report Cards, Response to Intervention (RTI) Reports, and Progress Notes will be provided to parents throughout the school year to communicate individual student progress.*
- ✓ **Parent-Teacher Conferences will be held throughout the school year to discuss individual student's achievement and plans for academic success.**
- ✓ **Provide parents reasonable access to staff. Specifically, Staff will be available for consultation with parents as follows:**
 - *Staff is available to meet with Parents before and after school and by appointment during school hours.*
 - *Parents are able to access school staff by phone, district e-mail, school website, Home-School Notebook, letters and conferences.*
- ✓ **Provide parent opportunities to volunteer and participate in their children's classes, and to observe classroom activities, as follows:**
 - *Parents are encouraged to volunteer in classrooms, accompany classes on field study trips and participate in special activities and school-wide events. The Parent Liaison will keep parents abreast of opportunities and coordinate parent volunteer services and participation.*

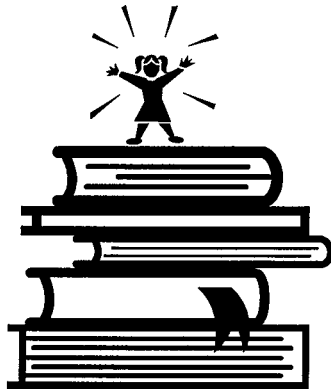
