V. Superintendent Report:

East EPO Superintendent Shaun Nelms shared that the East High School graduation rate is expected to increase to 61.1% this school year from 51.7% 2017-18 school year. He also reported there has been a decrease in the dropout rate. Superintendent Nelms indicated that the chronic absenteeism has decreased also by 22%. Dr. Nelms indicated East would be hosting a Summer Programming for staff, parents and students. Dr. Sonia James-Wilson will facilitate a 5-day workshop for staff on Culturally Relevant and Responsive Pedagogy. The Summer Training Institute for Parents will involve workshops for parents to help their children prepare for high school, professional learning to help parents understand graduation requirements, and encourage parents to participate on FACE (Family and Community Engagement) Committee. Step to College Summer Programming for students will provide high school scholars with an opportunity to experience the expectations and rigor of college through academic, social, recreational and community related experiences. Scholars will also learn about the college process, financial aid requirements, mentorship, appropriate college conduct, and college level academics.

VII. Review of Cohort (Graduation Data)

Robert Ullman with the Office Accountability presented the 2015 Total Cohort Graduation Rates (June 2019 Graduation Year) with end of marking period three results. Mr. Ullman explained there are two criteria for students to meet in order to graduate that include students who have received 16 credits as defined by the Academic Standards and Assessment Policy promotional guidelines and students who have 3 passing exams scores that include Regents, CDOS (Career Development and Occupational Studies and CTE (Career in Technical Education. Mr. Ullman reported the projection of June 2019 graduation rate is 60.1percent that would exceed the June 2018 graduation rate that was 53.5 percent. Mr. Ullman also reported the June 2015 total cohort projection of 60.1 percent includes East High School. As of marking period three, the Tracking Student Performance indicates 66.4 percent students are projected to graduate including East High School scholars that have met ASAP guidelines. The data also reveals 56.3 percent of students are projected to graduate that have 16 credits and 3 passing exams scores. Mr. Ullman reported there is an overall decrease of 2.6 percent in the student drop out.

Superintendent Lowengard stated although the District has a long way to go in making gains in student graduation, the District is moving in the right direction.
