## **Minutes**

President Evans convened the meeting at 6:30 p.m.

## Discussion

Commissioner Elliott asked if any of the personnel appointed by Resolutions No. 2008-09: 987-997 were of color. Ms. Barclay responded that there is person of color being appointed by the resolutions being considered. Commissioner Elliott asked what is the District doing to address the recruitment of persons of color. Ms. Hancock explained that the District has put systems and initiatives in place to identify candidates of color and those that have an understanding of the culture and diversity that exists in an urban environment.

Commissioner White asked if there has been a reduction in staff of the Special Education department. Superintendent Brizard said that the District is currently overstaffed in Special Education department and there are steps being taken to right-size the department's administration and class-size.
