ACCESS TO EDUCATION, STUDENT PRIVACY, LAW AND IMMIGRATION ENFORCEMENT POLICY - 5600

WHEREAS, it is the right of every child, regardless of immigration status, to access a free public K-12 education and the District welcomes and supports all students;

WHEREAS, the District has a responsibility to ensure that all students who reside within its boundaries, regardless of immigration status, can safely access a free public K-12 education;

WHEREAS, law enforcement activities, whether by federal immigration officials or state or other federal agents on or around District property and transportation routes, whether by surveillance, interview, demand for information, arrest, detention, or any other means, may disrupt the learning environment to which all students, regardless of immigration status, are entitled, and may significantly interfere with the ability of all students, including U.S. citizen students and students who hold other legal grounds for presence in the U.S., to access a free public K-12 education;

WHEREAS, through its policies and practices, the District has made a commitment to a quality education for all students, which includes a safe and stable learning environment, means of transportation to and from school sites, the preservation of classroom hours for educational instruction, and the requirement of school attendance;

WHEREAS, the Policy Development and Review Committee of the Board of Education received and has recommended to the Board of Education the adoption of the Access to Education, Student Privacy, Law and Immigration Enforcement policy (5600) in accordance with Board Policy 2410, "Formulation, Adoption and Amendment of Policies"; therefore be it

RESOLVED, that the Board of Education hereby adopts **Policy 5600**, "Access to Education, Student Privacy, Law and Immigration Enforcement", as set forth in the Policy filed with the Clerk of the Board, and incorporated by reference herein, and directs that the Clerk update the Rochester City School Board Policy Manual accordingly.

BE IT FURTHER RESOLVED, that the U.S. Immigrations Enforcement Office (ICE), state or local law enforcement agencies acting on behalf of ICE, or agents or officers for any federal, state, or local agency attempting to enforce federal immigration (or other) laws, are to follow District Policy 5600, attached to and incorporated in this Resolution, to ensure the District meets its duty to provide all students, regardless of immigration status, access to a free public K-12 education;

BE IT FURTHER RESOLVED, that the Board declares the District to be a place for students to learn, to thrive and to seek assistance, information, and support related to any law enforcement activity that interferes with their learning experience;

BE IT FURTHER RESOLVED, it continues to be the policy of the District not to allow any individual or organization to enter a school site if the educational setting would be disrupted by that visit; any request by ICE or other law enforcement agencies to visit a school site should be presented to the Superintendent's Office and the Office of General Counsel for review as to whether access to the site is permitted by law, a judicial warrant is required, or any other legal considerations apply; this review should be made expeditiously, but before any law enforcement agent or officer is granted access at a school site;

BE IT FURTHER RESOLVED, in its continued commitment to the protection of student privacy, the District shall review its record-keeping policies and practices to ensure that no data is being collected with respect to students' immigration status or place of birth; and cease any such collection as it is irrelevant to the educational enterprise and potentially discriminatory;

BE IT FURTHER RESOLVED, should ICE or other law enforcement agents request any student information, the request should be referred to the Superintendent's Office and the Office of General Counsel to ensure compliance with the Family Educational Rights and Privacy Act (FERPA), student constitutional privacy, standards for a judicial warrant, and any other limitation on disclosure; this review should be conducted expeditiously, but before any access or production of information is made;

BE IT FURTHER RESOLVED, the District shall post this Resolution at every school site and distribute it to District staff, students, and parents using usual means of communication, and that the Resolution will be translated into all languages spoken by students at home;

BE IT FURTHER RESOLVED, in the event law enforcement personnel request access to a school site or request student information, the Superintendent shall report back to the Board at its next meeting on compliance with this Resolution.

Whereas, Section 9 of the Act requires that the design of the FMP projects be reviewed and approved by the District and the design and construction standards be approved by the State Education Department; and

Whereas, by the following Resolutions, the Board approved the design of various Phase I projects as well as additions to the scope of Phase I: Resolution No. 2011-12: 413 (December 15, 2011), Resolution No. 2011-12: 480 (January 26, 2012), Resolution No. 2011-12: 867 (June 28, 2012), Resolution Nos. 2012-13: 227 and 228 (September 27, 2012), Resolution Nos. 2012-13: 364, 365 and 366 (December 13, 2012), Resolution Nos. 2012-13: 424 and 425 (January 24, 2013); and

Whereas, the total of \$2,600,000 for Phase I borrowing is uncommitted and available to fund additional projects beyond the scope of those currently approved for Phase I; and

Whereas, the Rochester City School District ("District") and Monroe Community College ("MCC") wish to work collaboratively to provide academic and student services for 11th and 12th grade students of Rochester Early College International High School, whereby students enroll in one of three alternative course offerings and receive services onsite at the MCC State Street Campus; and

Whereas, the students may choose to enroll in either: *MCC only* classes, a combination of both *District and MCC* classes, or *District only* classes, and receive the opportunity to combine the experiences of high school and college, culminating in the attainment of a high school diploma and the accumulation of college coursework; therefore be it

Resolved, that the Superintendent, or designee, be, and hereby is, authorized to enter into an Agreement with **Monroe Community College**, 1000 East Henrietta Road, Rochester, NY, to work collaboratively with the District and provide academic and student services for approximately 124 students of Rochester Early College International High School, for the period September 1, 2017, or as soon thereafter as the Agreement is fully executed, through June 30, 2018, at no charge for each student enrolled in *MCC only* classes, a sum not to exceed Four Thousand Seven Hundred Twenty One Dollars (\$4,721.00) per student enrolled in a combination of *District and MCC* classes or Seven Thousand One Hundred Six Dollars (\$7,106.00) per student enrolled in *District only* classes, funded by the Rochester Early College International High School and/or appropriate grant(s), through Rochester Early College International High School, contingent upon grant funding and budget appropriations and contingent upon the form and terms of the Agreement being approved by Counsel to the District.
