Whereas, the Act created the Rochester Joint Schools Construction Board ("RJSCB"); and designated the RJSCB as agent for the City, the District, or both; and

Whereas, the Act authorized the RJSCB to enter into a cooperative agreement with the City and the District to carry out the purposes of the Act, and the FMP; and

Whereas, the Act requires all contracts entered into by the RJSCB for FMP projects be managed by an independent Program Manager; and

Whereas, in an effort to prevent a lapse in construction and allow for a seamless transition from Phase 1 to Phase 2 of the FMP, and in an effort to strengthen oversight, transparency and accountability, the State Legislature amended the Act by enacting Chapter 533 of the Laws of 2014, thereby providing alternative financing mechanisms for the reconstruction of up to twenty six projects, up to a total cost of \$435,000,000, and by stipulating that the Program Manager selected for Phase 2 is subject to approval by the Superintendent, Mayor, City Council and the District; and

Whereas, it is the consensus of the RJSCB Selection Committee to enter into exclusive negotiations with Dewolff Epic LLC, to serve as the independent Program Manager for Phase 2 of the FMP; and

Whereas, these exclusive negotiations will provide the RJSCB the opportunity to review additional requirements and gather additional information that is necessary before entering into a formal contract; and

Whereas, the Superintendent and the Board of Education of the District approve the recommendation of the RJSCB Selection Committee to enter into exclusive negotiations with Dewolff Epic LLC, to serve as the independent Program Manager for Phase 2 of the FMP; therefore be it

and supports for improving academic achievement among African American and Latino boys; and

Whereas, the 2015-16 School Comprehensive Education Plan affirms the grade 3-8 Boys Academy as in integral part of improvement plans, and was formally reviewed and signed by the school based leadership team, the superintendent and school board president and forwarded on July 31, 2015 to the New York State Department of Education; and

Whereas, correspondence to the families of boys in grades 6 and 7 from the superintendent in June 2015, stating that they would attend the Young Mens Leadership Academy at the Charlotte campus in Fall 2015, was premature and not backed by the School Comprehensive Education Plan for School 9 or by any authorization from the Board of Education or from the State Commissioner of Education; and

Whereas, the powers of superintendent as receiver established by state law did not become effective for School 9 prior to mid-July 2015; and

Whereas, receivership regulations clearly state that any improvement plan developed by the superintendent receiver must include specific community engagement processes and Community Engagement Team recommendations prior to approval by the state Commissioner of Education; and

Whereas, there has been no new school improvement plan submitted by the superintendent according to receivership regulations to the Commissioner of Education for consideration of any proposed changes to the grade configuration or program characteristics of the Boys Academy at School No. 9; and

Whereas, a formal letter of complaint was sent to the New York State Department of Education by concerned parents and community members which included, but was not limited to, the following alleged violations of local policies and state and federal laws:

- 1. the action taken via the June 18, 2015 letter to parents given to 6th and 7th grade boys for delivery to their parents violated some or all of the students'/parents' rights to timely notification and their right to receive information in an understandable format in a language the parent is able to understand;
- 2. rights to school choice were violated for both the 6th and 7th grade Boys Academy students, and for other students who may have selected School No. 9 Boys Academy in the district wide school choice process in which the Boys Academy was offered as a city wide option for entering 7th grade students;
- 3. IDEA provisions appear to have been violated including a parent's right to be included and involved in decisions regarding placement; a right to schedule and hold a meeting to discuss, recommend or decide a change in placement; a right to least restrictive environment by abruptly reassigning students without review of needed special education services contained in their Individualized Education Program (IEP), and right to due process; therefore be it

Resolved, the Boys Academy will remain intact at School No. 9 in grades 3-8 until such time as the Commissioner of Education approves a plan to change the grade configuration and/or program characteristics; and be it further

Resolved, the superintendent is encouraged to work with the school based leadership team, students, families, the Board of Education and concerned community members to develop a proposal for transitioning the Boys Academy in a coherent and educationally sound way to the Charlotte Campus in fall 2016.

Seconded by Member of the Board Commissioner Powell Rejected 2-4 with Vice President Elliott absent and President White, Commissioner Campos, Commissioner Cruz, and Commissioner Evans dissenting

Whereas, the Board wishes to the continue to support the RPPP, UPK and related early childhood education initiatives that encourage parent participation in instructional and socialization programming; therefore be it

Resolved that, RPPP will maintain program integrity, including budget allocated by the Board in the 2015-16 budget; and be it further

Resolved that, the Board directs the Superintendent or designee to provide quarterly updates that articulate the level of parent participation in the District's RPPP initiatives; collaborative efforts with community partners; and progress against standards of quality in all of the District's early childhood education programs including but not limited to teacher qualifications and professional development, developmentally appropriate practice and learning, and effective practices that encourage parental involvement and student success.
