- ❖ Governance Matrix Review. Commissioners reviewed the work to be completed by the Committee this year.
- ❖ Superintendent Evaluation Top 6 Goals: Achieve a 5% increase in the graduation rate between August 2019 and August 2020. Increase student proficiency in ELA and math by 7% by August 2020. Reduce the disproportionate special education classification of students of color and the disproportionate suspension of students of color by 1.5% by 2020; and increase the enrollment of students of color in advanced coursework by 5% by June 2020. Reduce chronic absenteeism by 5% by June 2020. In order to better define family engagement by June 2020, we will ensure there is an active Student Leadership Group in all high schools and that all schools will meaningfully engage families in the School-Based Planning Team process, in accordance with the School-Based Planning Team manual. Achieve and maintain fiscal stability by implementing a plan that will put the District on secure financial footing.

- The Board member shall state the purpose for this request, so the other Board members can make an informed decision.
- The Board shall take a vote to go into executive session to review the personnel file(s) requested.
- Any discussion about the basis for the request that involves discussing the particular employee(s) should be done in executive session.
- If there is no need for discussion of specific employee(s), the Board shall vote immediately.
- If a majority of the Board votes to adjourn to executive session for this purpose, then the personnel file(s) shall be shared in executive session.
