Whereas, a collective of citizens and community groups organized as Greater Rochester Area Coalition for Education (GRACE) has commenced litigation entitled Paynter v. State of New York, presently pending in the New York State Court of Appeals, asserting that the State must control the composition of each school district's student body so as to ensure that racial isolation and concentrations of poverty do not preclude students from obtaining a sound basic education; and

Whereas, throughout the litigation, the GRACE plaintiffs made it abundantly clear that they ascribed racial and poverty concentrations in urban school districts to State action in the

form of zoning and housing policy; the State's configuration of school district boundaries; and State law determining eligibility for school attendance; and did not attribute poor education outcomes to the Rochester City School District, as a result of which the District was dismissed as a party by the New York State Supreme Court, which decision was affirmed by the Appellate Division, Fourth Department; and

Whereas, the Board of Education, based upon its long-standing experience, concurs with the essential premise of the plaintiffs that racial isolation and overwhelming concentrations of poverty do foster disproportionate need for special services; and do significantly complicate the potential for any urban or rural district to consistently deliver sufficient, focused services to its students; and do significantly effect the ability of individual students to overcome the impediments of their impoverished environments; and

Whereas, while of the opinion that remedies different from those being advanced by the GRACE plaintiffs offer greater potential for success and acceptance in the near term, and notwithstanding the superlative accomplishments of many of the students who attend Rochester City Schools, the Board of Education agrees that dramatic action is necessary to educate and mobilize the larger community of this State to the imperative of a new educational model, with adequate State funding and initiatives targeted to the communities of greatest need; it is, therefore,

RESOLVED, that the Board of Education of the City of Rochester commends the citizens and community groups constituting GRACE, for their focused and determined effort to bring public attention to the need for dramatic action to serve those students of New York State who must labor toward adulthood and citizenship under the yoke of poverty, racial or linguistic isolation; and joins in their call for the State of New York to devise a method or methods by which the resources of the State, including but not limited to financial resources, will become focused and targeted to maximize the potential for fully educating the poorest and most isolated of our children, and to break at last the cycle of poverty which destroys the lives of our children and impairs the future of every person residing in the State of New York.
