Whereas, the Board of Education is fully committed to safeguarding transportation aid surpluses for transportation purposes upon return to in-person instruction, therefore be it Resolved, that the Board of Education calls for the creation of a committed fund balance of \$23,100,000 for transportation purposes in lieu of the existing assigned fund balance of the same amount.
