All ASAR members must also have 15 years of continuous service with the District immediately preceding retirement, or 20 years of total service with the District, including 5 years of continuous service immediately preceding retirement.
- 3. The District will pay each member eligible for this Retirement Incentive Plan \$25,000 in one of four ways as determined by the member: lump sum payment in a separate paycheck; or by deposit into a District-sponsored tax sheltered investment plan (457 Plan); by deposit into an elective 403(b) plan; or as a credit to be administered by the

District for the member's use in retirement to enhance standard health and dental benefits.

4. Eligible ASAR members must notify the Chief Human Resources Officer between January 3, 2008 and February 25, 2008 of their irrevocable intent to retire. Retirement dates must be effective for Certificated ASAR members between July 1, 2008 and August 31, 2008 and must be effective for Civil Service ASAR members between July 1, 2008 and September 30, 2008.
