1. Welcome by Sally Bub

2. April Minutes: Motion to approve by Cathy, seconded by Molly. Minutes approved.

3. Nomination of New Members: (Colleen):

Sally will email members asking for nominations of new members—2 elementary and 1 secondary. Once nominations are in, all members will vote by survey. Council must approve vote. By-laws will be reviewed to make sure we are following procedure.

4. Reports

- a) SLS Director (Colleen)
 - a. Staffing updates—HCI is drawing up contracts for librarians to fill positions at 2 schools. 4 library positions are open.
 - b. Budget update—Colleen had emailed librarians to spend/encumber the large outstanding balance in library funds. The amount was greatly reduced.

SLS is purchasing *Cybersmarts* eBooks for RCSD 3-6th grades, and in July will add 7-12th. SLS is purchasing *Spotlight on NY* database.

The Budget was passed, and City has to approve. Libraries will receive almost triple the amount of funding for 2015-16.

c. SLS purchased one organizational membership in NYLA—primary is Colleen and secondary is Sally.

Colleen led a discussion about NYLA/SSL memberships for all

RCSD librarians. Sarah made a motion to approve purchase of organizational memberships in NYLA/SSL for every RCSD

Librarian. Molly seconded the motion. The motion was approved.

d. Extra pay—discussion about the desire to compensate librarians who do extra work such as ROCRead lead, eBooks, cataloging and Destiny support. Possibilities are paying an amount per hour or paying sub so that librarian can use ½ days for the extra work.

b) RRLC (Colleen)

• Arnett and Maplewood were selected as RRLC Public Library of the Year (winner and honorable mention, respectively)..

c) RPL (Sarah L)

- Arnett purchased a book bike, which was funded by a Harold Hacker Grant through the Friends and Foundation of the Rochester Public Library.
- Shared the Summer Reading paper—"Every Hero has a Story"
- Learning Labs at branches. Sarah will recheck age groups that may participate.
- A StoryCorps grant is funding stipend and oral history kit June to October, focusing on new Americans. This project will begin at Maplewood in June.
- Sarah offered to visit any schools that may wish to have her promote Summer Reading programming.
