Ms. Fuller and Ms. Rich will provide an overview of what they have in place. Wednesday two times throughout the day and Thursday October 22 Evening Parents can sign-up on www.Signup.com for 10 minute meetings with teachers. They can choose what kind of conference they would like (phone or Zoom). Teachers are being asked to email parents the zoom link using the email parents used when signing-up for a meeting. The maximum number of parents that can meet with a teacher is 37. If a parent really wants to meet with the teacher, they can contact the teacher to schedule a meeting at a different time. If parents miss their meeting, teachers are being asked to be flexible to reschedule them for another meeting. Parent of ELLs would need to be coordinated for Language Line to be used. We cannot add a section for Translator Needed on signup.com unless we upgrade An idea for Edison to consider: instead of PTC, we will have an Open House format. On Wednesday, October 21 during the day we can offer families the opportunity to visit their child's classrooms via Zoom and can follow their child's schedule as they would in a remote setting.
