 - a. Last year every title on the list was purchased for grades
 K-2 and there were 2 copies at every branch
 - Central purchases the books and stores them during the school year because the other branches don't have enough space
 - c. Tonia needs the list of titles by May 1st because it is the spending cut off
- ii. Summer Reading Program
 - 1. Unsure of what the summer reading program will look like as of right now

- 2. County Wide Nature Challenge
 - a. The Nature Team is launching a county wide initiative to invite families to explore nature this summer
 - RPL will be creating Nature Backpacks and make them available to all recreation centers, scout groups, schools, and library patrons
