Whereas, the Board of Education of the Rochester City School District, by Resolution No. 2003-04: 759, adopted at a Special Meeting of the Board held on May 18, 2004, the budget estimates for the 2004-05 fiscal year, in the total amount of \$575,814,029, which budget estimates included New York State General Fund Revenues in the amount of \$313,327,326 and City of Rochester revenues in the amount of \$126,100,000; and

Whereas, the Board at a Special Meeting of the Board held on June 22, 2004 authorized the Superintendent to reduce and/or freeze \$6.4 million in order to adjust for the \$7 million revenue reduction from the City of Rochester; and

Whereas, the City School District of Rochester has also had to incur \$4.3 million in expenses for school nurse services previously provided by the County of Monroe; and

Whereas, the City School District of Rochester will receive \$3.1 million less in revenue from State and Federal categorical grants; and

Whereas, the New York State Budget, adopted on August 10, 2004, provided for \$304 million in general fund aid to the Rochester City School District; and

Whereas, the Board recognizes that in this current fiscal situation budget adjustments may be necessary; it is therefore

Resolved, that the Superintendent is granted the authority and flexibility to further reduce or curtail expenses, as needed, for the 2004-05 fiscal year in order to assure a balanced budget; and it is further

Resolved, that the Board authorizes the Superintendent to make budget reductions in an amount up to \$13,276,910, as set forth in the Superintendent's proposal, dated August 19, 2004, attached herewith; and it is further

Resolved, that the Board authorizes the Superintendent to make adjustments as needed and when necessary from the above-referenced proposal; and it is further

Resolved, that the Board directs that in the event the Rochester City School District receives additional spin-up revenue for the 2004-05 fiscal year, the Superintendent will recommend restorations to the Board; and it is further

Resolved, that the Board directs the Superintendent to submit an amended budget for the 2004-05 fiscal year following the final New York State runs in November 2004.
