Ratifying Collective Bargaining Agreement with The Per Diem Substitute Teachers Unit of the Rochester Teachers Association (NYSUT/AFT-AFL-CIO)

Whereas, the negotiators representing the Superintendent of Schools and the Per Diem Substitute Teachers Unit of the Rochester Teachers' Association have met and reached a tentative collective bargaining agreement for the period July 1, 2004 through June 30, 2006; and

Whereas the Superintendent of Schools and the membership of the Per Diem Substitute Teachers Unit have ratified the agreement; therefore, be it

Resolved, that pursuant to the provisions of Civil Service Law sections 201 and 204-a, the Board of Education approves the following new, or modified from the previous agreement, economic provisions:

1. Elimination of provision in previous agreement that set daily rates for per diem substitutes as $1/400^{\text{th}}$ of the starting salary for RTA teacher unit members and adding a provision setting three tiers of per diem wage rates: Effective July 1, 2004: Tier 1 - \$92.70; Tier 2 (50 day rate) - \$137.33; Tier 3 (100 day rate) - \$146.56; effective July 1, 2005: Tier 1 - \$96.82; Tier 2 - \$143.44; Tier 3 - \$153.07.
2. Effective July 1, 2004, a teacher in a continuing assignment (long term substitute) will move to $1/200^{\text{th}}$ of a beginning teacher salary after completing 45 days in the continuing assignment. Benefits remain unchanged and are provided after the completion of 60 days in a continuing assignment.
3. The daily rate for a per diem substitute assigned to an itinerant position is increased by \$6.00 per day instead of by \$4.00 per day as in the previous agreement.
4. Per Diem, Building and Long Term Substitutes who are injured on school premises by a student, staff or non-staff during a school day will be paid their daily rate for all days hospitalized up to a maximum of 5 days.
