- ◆ Academic Standards and Assessment Policy both of which affirm the

strong belief that the learning environment must be structured to reflect: “diverse cultural traditions and contributions,” *and* “the diverse learning and cultural needs of all students;” and the

- ◆ Civic Values Policy which identifies *Diversity* as a value that “enriches an individual’s life experiences,” and states that “the success of American democracy depends upon a demonstration of respect for individual difference;” and

Whereas, despite our best efforts, the rich tapestry and importance of African American participation in the development of our country remains under-illuminated; and

Whereas, we must vigilantly remind all of us that America is a “culturally pluralistic society” and that our schools play a major role in shaping the attitudes and beliefs of the nation’s youth and that history is a primary medium for transmitting positive ideas about our past; therefore be it

Resolved, That the Board of Education acknowledges the significant contributions of African Americans to the history of our country and of this city, and hereby designates February 2003 as ***Black History Month*** in the Rochester City Schools; and be it further

Resolved, That, the Board of Education endorses the observance of ***Black History Month*** and encourages all teachers, staff, parents, and students to celebrate the month in our schools.

Whereas, the District's Vision of a "high performance school system characterized by high expectations" can only be achieved by ensuring equal educational challenges and opportunities for all students, regardless of gender; and

Whereas, the study of women in history will raise the level of awareness of women's contributions for all students, counteract negative female stereotypes, and provide exemplary role models to support and encourage girls to reach their highest goals; Therefore, be it,

Resolved, that the Rochester City School District Board of Education endorses the observance of **National Women's History Month** during March and will celebrate with a special program, and be it further,

**Resolution No. 2002-03: 631**

Whereas it is the desire of the Superintendent of Schools to address serious enrollment concerns at the middle- and high-school levels (due to the "bubble" passing through Rochester's middle and high schools), to be fiscally responsible, and to forward a solution that provides the least disruption to students and schools. Whereas fewer school transitions and major school restructuring present a new opportunity to improve school climate and student achievement and thus provides the opportunity to address Rochester's middle grades academic achievement problems. Whereas it is Board policy to, over the 2003-2004 academic year, create greater choice within three *Parent Preference / Managed Choice* zones, the Superintendent of Schools is forwarding to the Board of Education a comprehensive, two-part but integrally connected, plan for redesigning Rochester City Schools.

Whereas, it is the desire of the Rochester Board of Education to consider this redesign proposal in two parts, the first of which is a K-6 school configuration. Whereas

the Superintendent and Board of Education desire to establish – to the extent feasible – a common grade configuration for elementary students. Whereas 17 of the District's 39 existing elementary schools are currently organized as K-6 buildings. Whereas the Board of Education requires annual reports on the progress of the K-6 redesign and annual updates of the progress of the K-6 buildings in relation to the *Parent Preference / Managed Choice Policy*. Whereas the Board of Education requests the completion of a formal evaluation of the K-6 configuration after three years of implementation. And whereas, 6<sup>th</sup>-grade students being educated in K-6 buildings are achieving at higher levels than (and behaving better than) their 6<sup>th</sup> grade counterparts in middle schools be it

Resolved that the following elementary schools will accept 6<sup>th</sup> grade students for the 2003-2004 school year:

- School 2 to become a K-6 in 2003-2004
- School 4 to become a K-6 in 2003-2004
- School 5 to become a K-6 in 2003-2004
- School 6 to become a K-6 in 2003-2004
- School 9 to become a K-6 in 2003-2004
- School 12 to become a K-6 in 2003-2004
- School 15 to become a K-6 in 2003-2004
- School 16 to become a K-6 in 2003-2004
- School 17 to become a K-6 in 2003-2004
- School 19 to become a K-6 in 2003-2004
- School 22 to become a K-6 in 2003-2004
- School 28 to remain a K-6 but to also accept its 5<sup>th</sup> grade Bilingual and 5<sup>th</sup> grade MAP students in 2003-2004
- School 29 to become a K-6 in 2003-2004
- School 33 to become a K-6 in 2003-2004
- School 36 to become a K-6 in 2003-2004
- School 45 to become a K-6 in 2003-2004
- School 54 to become a 3-6 in 2003-2004

And the following elementary schools will accept 3<sup>rd</sup> grade students for the 2003-2004 school year:

- School 25 to become a K-3 in 2003-2004

And the following elementary / middle school will move to becoming a true K-8 by 2006-2007:

- School 3 to accept fewer 6<sup>th</sup> graders in 2003-2004 and more elementary students in 2003-2004 to become a true K-8 over the next several years.

And the following elementary schools will accept 6<sup>th</sup> grade students for the 2004-2005 school year:

- School 35 to become a K-6 in 2004-2005
- School 50 to become a K-6 in 2004-2005

- School 52 to become a K-6 in 2004-2005
