Electing to Extend the in 2002 NYS Retirement Incentive Program to Employees in the ASAR Bargaining Unit

Whereas, the State of New York has adopted legislation in the form of "...an act to provide a temporary retirement incentive to its employees; and to provide an age 55/25 temporary incentive for certain public employees" under which employees of school districts are included in the potentially eligible class; and

Whereas, the Rochester City School District, prior to the enactment of the State legislation had made a Voluntary Early Separation Agreement (VESA) available to employees meeting minimum salary and age criteria, under which the District's unions had agreed that in the event that any State incentive program were to be offered prior to an employee's date of separation, and the District offered such incentive, the individual employee would be permitted an election: to separate under the VESA agreement, or, to annul that election and separate instead under the terms of the State incentive; and

Whereas, that as mandated by Section 2(c) and Section 8 of Part A of the enabling legislation, the Board of Education has determined that adopting of the Part A (service credit incentive) shall achieve savings to the District as a result of turnover savings; and

Whereas, the New York State Teachers' Retirement System has asserted the effective retirement dates under Part A must occur within the open enrollment period, and cannot be effective at other times even if within the statutory limits of the incentive (August 31, 2002 for education employers); and the State legislation also requires written notice to the employer no less than twenty-one days before the end of the open enrollment period; it is

Resolved that, subject to the limitations, procedures and requirements set forth in the enabling legislation, the Board of Education of the Rochester City School District hereby elects to participate in Part A of the 2002 New York State retirement incentive program adopted by the State Legislature and approved by the Governor, for employees who are members of the Association of Supervisors and Administrators of Rochester, subject to the limitations set forth in this Resolution, and in accordance with the provisions of law and it is

Further resolved, that for employees identified by this Resolution as eligible for the state incentive, who have already elected to retire under VESA but are eligible to participate in the 2002 New York State retirement incentive legislation, and who choose to retire under either of those incentives, such employees will be permitted to retire under their choice of one of the New York State retirement incentives for which they qualify instead of VESA, and the VESA election will be annulled subject to the express terms of each individual employee's VESA letter and election document, provided that the effective date of the retirement/resignation has not already passed, and it is

Further resolved, that a choice of one the State incentives shall be available to District employees identified by this Resolution, who were not eligible for, or who did not elect to participate in the VESA program, provided that they meet the qualifying criteria of the State legislation, and it is

Further resolved, that to accommodate the State's position that effective retirement dates must occur within the open enrollment period, open enrollment period for the Part A incentive shall run from June 3, 2002 through August 31, 2002 (coextensive with the period for RTA members), and employees opting to retire under that section shall file a service retirement application with the State retirement system at least fourteen (14) days prior to the effective date of retirement, which effective retirement date must be no later than August 31, 2002 in order to meet the requirements being set by the State for its program; and retirement papers under Part B must be within the time frames set by the State legislation; and it is

Further resolved, that to meet the planning objectives of the District, and/or certain notice requirements of the State legislation, any ASAR member who was timely enrolled for the District's VESA program, who intends to elect instead to take either Part

A (Service Credits) or Part B (Age 55/25 Year Service Retirement) of the 2002 NYS Retirement Incentive must notify the District Department of Human Resources, in writing, such notice to be actually received by Human Resources as soon as possible but no later than 4:00 PM on Friday, July 5, 2002; and it is.

Further resolved, that to meet the planning objectives of the District and/or certain notice requirements of the State legislation, any ASAR member who was not registered for the District VESA but who intends to take either Part A (Service Credits) or Part B (Age 55/25 Year Service Retirement) of the 2002 NYS Retirement Incentive must notify the District Department of Human Resources, in writing, such notice to be actually received in Human Resources no later than 4:00 PM on Friday, July 5, 2002.

Whereas, several current Article IV employees transferred into Article IV status from collective bargaining unit positions which conferred tenure and benefits upon them, which they relinquished in reliance on benefits promised to them under Article IV; and

Whereas, several current Article IV employees were induced to accept at-will positions within Article IV in part in reliance on Article IV benefits, and other current employees have continued their employment in part in reliance upon the assurance of continuation of such benefits, now, therefore, be it

RESOLVED, that the Board of Education concurs with the recommendation of the Policy Committee, unanimously adopted at a meeting of the Policy Committee held on June 11, 2002, and hereby authorizes that, effective immediately, Article IV benefits, as set forth in the Rules and Regulations of the Board of Education adopted on December 21, 2000, shall continue in effect for all Article IV employees currently on the payroll, as of the date of this resolution; and that any modifications to the existing Article IV Rules

and Regulations reducing or eliminating benefits be applied prospectively to new hires, and it is

FURTHER RESOLVED, that a moratorium be and hereby is effective immediately, to continue through September 30, 2002, on hiring Article IV employees by the Superintendent, except where the Board of Education has, on a case by case basis, concurred regarding the proposal for benefits to apply to an offer of employment to any such new hire during the period under which the benefit package is under review; and it is
