Re-approving Extension of the 2002 NYS Retirement Incentive to
District Employees Who Are Members of the
New York State & Local Employees Retirement System

WHEREAS, pursuant to Resolutions numbered 2001-2002:847, as amended by 847A; and Resolution 911 adopted on June 13, 2002; and Resolutions numbered 915; 916 and 917, adopted on June 21, 2002, the Board of Education elected to offer Part A of the 2002 New York State Retirement Incentive to all members of all of its collective bargaining units, and to permit those employees meeting eligibility requirements for both the State incentive and the District's voluntary early separation plan to make an election; and

WHEREAS, the New York State & Local Retirement System has advised that it will not approve the resolutions organized by bargaining group and encourages instead the use of the System's own recommended resolution; it is

RESOLVED, that the Board of Education of the Rochester City School District does hereby elect to provide the benefits of Part A of Chapter 69 of the Laws of 2002, commencing on June 21, 2002 and extending through August 31, 2002 for all eligible employees who retire with an effective date of retirement set during the seventy-one (71) day period beginning with and immediately following the commencement date and who are otherwise eligible as specified by Part A of Chapter 69, Laws of 2002; and it is

FURTHER RESOLVED, that all other provisions of Resolutions numbered 2001-2002:847, as amended by 847A; and Resolution 911 adopted on June 13, 2002; and Resolutions numbered 915; 916 and 917, adopted on June 21, 2002, including provisions relating to election between State and local incentives are expressly reaffirmed; and that for employees directly appointed by the Superintendent, who are covered by this Resolution but were not within the scope of the foregoing Resolutions, and who are also eligible for the District's VESA program must make their election between the state and local incentives, in writing, to the District Human Resources Department before 4:00 PM on August 2, 2002.

Re-approving Extension of the 2002 NYS Retirement Incentive to District Employees Who Are Members of the NYS Teachers' Retirement System

RESOLVED, that the Board of Education of the Rochester City School District does hereby elect to provide the benefits of the 2002 **Part A** to all targeted employees who are members of the New York State Teachers' Retirement System and who retire with an effective date of retirement during the "open period" (not more than 90 days nor less than 30 days commencing on June 21, 2002 and ending on August 31, 2002, and who are otherwise eligible to participate in such program.
