Resolved, that pursuant to the provisions of Civil Service Law §§ 201 and 204-a, the Board of Education approves the tentative Memorandum of Agreement dated September 20, 2002, including the following economic provisions:

1. Within ninety (90) days of ratification by the Board of Education, and following the notice and application procedures set forth in the Memorandum of Agreement, the group of ASAR members shall be paid a sum, less deductions applicable by law, calculated on each eligible employee's 1987-1988 monthly base salary, upwardly adjusted in a manner consistent with the growth rate of the Putnam Income Fund (5.91% annually over fifteen years). The fifteen-year adjustment shall be deemed to be a liquidated claim, and no further adjustment shall be made to the amount due under the agreement in any individual case.
2. The parties have stipulated and agreed that there are approximately fourteen (14) individuals believed to be eligible, although eligibility shall be determined by the District in accordance with the eligibility standards of the Memorandum of Agreement following receipt and review of unit members' applications, and subject to the grievance procedure of the collective bargaining agreement.
3. The Chief Financial Officer is hereby authorized to make payments authorized under this Resolution from available funds within the approved 2002-2003 budget. The Chief Fiscal Officer shall report to the Finance Committee the amounts paid and funds used to meet the commitment. The payments

authorized by this Resolution shall fully satisfy the District's obligation concerning compensation under the 1987 collective bargaining agreement, and under Section 11(4)(d) of the 2001-2003 collective bargaining agreement, which clause shall be stricken from future collective bargaining agreements between the parties.

Evening Academy at Marshall

Whereas the arrival of new entrants to the City School District, the return of students from Rochester charter schools, and the introduction of specialty schools/academies in District high schools designed for small-school settings and that the Rochester City School District has experienced a significant enrollment increase in our middle and high schools and this growth is projected to continue through 2004-2005; and

Whereas the needs of our student population would benefit from a small-school setting that offers personal interaction and individualized attention from teachers; the

Superintendent of Schools proposes the creation of the Evening Academy at Marshall as a newly established program that will serve approximately 165 students in grades 9 and 10 and will meet from 3:00-7:10 p.m. Monday through Friday so that these students can take advantage of opportunities during the day such as school-to-work experiences (co-op, youth apprenticeship) or additional educational courses (community college, technical training); and

Whereas the Evening Academy at Marshall is expected to open in the second marking period (November) and will follow a semester schedule similar to college and will use block scheduling to provide longer blocks of instructional time; and whereby this program will require additional staff totaling nine teaching positions and carry a cost of \$578,424, which will be supported with funds already in the 2002-2003 budget.

Be it resolved that that the Board of Education adopts this resolution and authorizes the creation of the Evening Academy at Marshall as an instructional program within the Rochester City School District, effective at the start of the second marking period, November 2002, that the Evening Academy at Marshall will require annual reauthorization by the Board of Education; and that the Academy will be assigned its own school building number, separate budget line, and the position of John Marshall High Evening Program Administrator with full authority to administer the program budget, hire staff, and direct other operational duties associated with this program.
