**Resolution No. 2011-12: 519**

**WHEREAS**, from time to time, employees of the Rochester City School District ("School District") are named as parties in civil actions or proceedings in federal, state or local courts or before administrative agencies arising out of alleged acts or omissions which occurred or alleged in the charge or complaint to have occurred while the employees were acting within the scope of their public employment or duties, and

**WHEREAS**, Section 3811 of the Education Law requires, among other things, that school districts defend and indemnify any school board member, superintendent, principal, member of the teaching and supervisory staff, non-instructional employee, or any member of the committee on special education or subcommittee thereof, arising out of the exercise of their public employment or duties, and

**WHEREAS**, the Board of Education of the School District desires to provide for the defense and indemnification for all employees acting within the scope of their public employment or duties; now therefore it is

**RESOLVED**, that upon compliance by an employee with the provisions of any employment contract, which for the purposes of this resolution shall include any applicable collective bargaining agreement and/or rules and regulations relating to an employee group, the School District shall provide for the defense of the employee in any civil action or proceeding in any federal, state or local court or administrative agency arising out of any alleged act or omission which occurred or is alleged in the charge or complaint to have occurred while the employee was acting within the scope of the employee's public employment or duties, as shall be determined by the General Counsel. This duty to provide for a defense shall not arise where such civil action or proceeding is brought by or on behalf of the School District; and be it further

**RESOLVED**, that the School District shall indemnify and save harmless an employee in the amount of any judgment obtained against such employee in any federal, state or local court or administrative agency or in the amount of any settlement of a claim, in the nature of compensatory damages and punitive or exemplary damages, provided that the act or omission from which such judgment or settlement arose occurred while the employee was acting within the scope of the employee's public employment or duties as shall be determined by the General Counsel; the duty to indemnify and save harmless prescribed by this subsection shall not arise where the injury or damage resulted from intentional or willful wrongdoing on the part of the employee as shall be determined by the General Counsel; and be it further

**RESOLVED**, that as used herein, the term employee shall mean any person holding a position by election, appointment or employment in the service of the Board of Education of the Rochester City School District and/or the Rochester City School District, but shall not include

any independent contractor. The term "employee" shall include a former employee, her or his estate, or judicially appointed personal representative and shall include such other entities and natural persons as the School District is required to indemnify by law or contract; and be it further

**RESOLVED**, that this resolution is not intended to limit any obligations with regard to defense and indemnification under the New York Education Law, or School District collective bargaining agreements, rules and regulations for employee groups or employment contracts; and be it further

**RESOLVED** that the provisions of this resolution shall apply to all actions and proceedings pending upon the effective date hereof or hereafter instituted.
